## FESTIVAL AND CONFERENCE

### VENDOR RULES

1. Setup will be Thursday September 29, 8 am until 6 pm . The festival will open at 8 am Friday morning, September 30. Booths must be ready for business at that time.
2. Someone must be in attendance at each exhibit or concession stand at all times during show hours. Hours are 8 am until 6 pm Friday and 8 am until 6 pm on Saturday.
3. Early closer (without due cause) will constitute a \$10.00 early closer fee and the possibility that you will not be invited back again next year.
4. **Entry Fees are non-refundable**
5. Preferred craft items are rustic handmade items. No used or garage sale type items or dollar store type items will be considered. True antiques/collectables will be considered.
6. Booth space rent (see front)
7. Exhibitors will be responsible for their own display items and materials. The exhibitor is responsible for the appearance of the space during and at the close of the show. No trash is to be left at your booth site.
8. Acceptance constitutes a contract to use the space assigned by the festival personal and they retain the right to change spaces.
9. Prices must be clearly marked on items.
10. If you bring a pet it must be leashed or caged at all times.
